Rainforest Workshops, LLC will be working under the auspices of EcoTeach, Inc. for travel arrangements and logistics, including registration, accommodations, transportation, and contracts related to the onsite management of the field study in Peru. In this document Rainforest Workshops, LLC and EcoTeach, Inc. are collectively referred to as "EcoTeach".

REGISTRATION: Reservations are accepted and your space confirmed with the Group/School named above upon receipt of the three required registration/information forms accompanied by a deposit of \$400 per participant.

Payment of your deposit or any other amounts constitutes agreement with and acceptance of the following Terms & Conditions.

TERMS AND CONDITIONS

Limits of Liability: EcoTeach contracts with service providers for transportation, hotels, meals, guides and tours. These services are not under our control. If flights are contracted through EcoTeach, we work with major airlines and book on regularly scheduled flights. EcoTeach acts only in the capacity of agent as to flights, and has no liability in that role. The airlines' liability is limited to the terms of the airline tickets. EcoTeach is not liable for any delays, inconveniences, accidents, expense or mishap of any kind whatsoever resulting entirely, or in part, from the negligence or actions of others or from causes beyond its reasonable control. EcoTeach does not accept any responsibility for losses or additional expenses due to delay or change in air services, sickness, weather, strike, war, quarantine, or other causes beyond its reasonable control. All such losses or expenses will be borne by the participant, as tour rates provide for arrangements only for the time stated. EcoTeach reserves the right, in its sole discretion, to substitute modes of transportation and to make any changes in the itinerary where it deems necessary or appropriate in its sole discretion or caused by changes in air schedules or changes as to the services of other service providers. You agree that to the extent consistent with applicable law, the maximum amount of recovery to which you may be permitted to recover from EcoTeach shall not exceed the land cost of your trip with EcoTeach. To the maximum extent

permitted under applicable law, EcoTeach shall not be liable for any special, consequential, indirect, incidental or other damages, including lost profits, whether such damages arise in contract, negligence, tort, under statute, in equity, at law, or otherwise, even if EcoTeach has been advised of the possibility of such damages. You expressly waive any right you may have to recover such damages.

More Legalese: EcoTeach, its owners, and its associated agents act only as agents for the owners, contractors and suppliers providing means of transportation and/or all other related travel services and disclaim all liability for property loss or damage, and/or any damages or claims resulting from death, illness or personal injuries, including loss of services which may be sustained on account of, or rising out of, by reason of, or while engaged on any trip, automobile, boat, vehicle, horseback, canopy riggings, inn, common carrier, aircraft, interaction with other participants, or otherwise caused by failure, delay, or by any transportation or travel service company due to any cause whatsoever occurring during a tour under its management, sponsorship, procurement or otherwise. Basically, there are some things that are just not under EcoTeach's control.

Important Information on Flight Costs: For groups booking flights through EcoTeach a service fee of approximately \$30 per ticket will be assessed. Occasionally EcoTeach will purchase several blocks of tickets for a group at different prices and charge the averaged amount to the participants. Also, please be aware that taxes and fees imposed by the government are subject to change until the tickets are purchased (approximately 3 months prior to your departure date). Such changes are outside of EcoTeach control. After tickets have been purchased, if necessary you will receive a statement detailing the cost for airfare and an invoice for, and agree to pay such, additional charges, if any. Thanks in advance for your understanding.

Payments and Related Fees: Although the full payment is requested with the registration, the deposit plus three equal payments are acceptable. Unless otherwise stated, payments should be made to EcoTeach with the first payment due 7 months prior to departure, second payment due 5 months prior to departure, and the full payment due no later than 2 months prior to departure. ***Please consult your trip leader or group webpage for the exact program fee and payment dates.*** Please note that credit card payments incur a 3% processing fee.

A \$25 late fee will be imposed on all late payments. If any payment is not made by the required date, EcoTeach may, in its sole discretion, cancel the trip for that participant and impose the cancellation fee set forth above. Returned and NSF checks will be charged a \$15 fee.

Cancellation: To cancel from a trip you will need to complete and return a cancellation form, which can be found on your group webpage. You will remain an active participant until the cancellation form is received in our office. The cancellation fee schedule is as follows:

- **120 days plus prior to departure:** \$400 cancellation fee + any nonrefundable deposits / payments made on participant's behalf
- **119 to 60 days prior to departure:** \$600 cancellation fee + any nonrefundable deposits / payments made on participant's behalf
- **No refunds are available less than 60 days prior to travel.**

Nonrefundable payments made or costs incurred on participant's behalf include but are not limited to flight or hotel deposits, airline tickets, trip leader costs, etc.

If you leave a tour in progress, for any reason, it will not result in a refund, and no refunds will be made for any unused portions of a tour, including those that are the result of your removal from a tour and for reasons related to weather, terrorism, civil strife, personal, family or medical emergencies or any other circumstances beyond our control.

We strongly advise you purchase a travel protection plan that provides many insurance benefits and non-insurance assistance services.

Services Provided: Our trips are an exceptional value because they include nearly everything. The price includes: ground transportation, accommodations, hotels, naturalist/guides, meals and activities as specified in the itinerary, and departure taxes (unless otherwise specified). Costs not included are tips for guides and drivers, additional equipment rentals, specified optional activities and expenses of a personal nature. If a trip must be extended or an itinerary modified due to safety, weather, road conditions, lack of transportation, political or civil disputes, medical emergency or other causes beyond our reasonable control, all associated costs including any non-recoverable costs are not included in the trip rates or refunds.

Accommodations: Field sessions take place at established jungle lodges in the upper Amazon Basin of Northern Peru. These lodges are rustic, thatch-roofed, comfortable and clean. Each lodge houses private rooms equipped simply with a wash basin, mirror, shelves, and single beds each covered with mosquito netting. The kitchen, dining area, showers, latrines, and sleeping quarters are all connected by thatch-covered walkways. Meals are served buffet-style, featuring a variety of fresh fruits and vegetables, meat or fish, and desserts.

Medical Treatment / Medical Proxy / Release: Participant gives EcoTeach and their contractors permission to arrange emergency medical treatment for participants if deemed necessary in EcoTeach's sole discretion, and Participant agrees to hold EcoTeach harmless for the provision or non-provision of such services, and waives any and all claims for injury, illness or death arising from or relate to this proxy other than those claims arising from EcoTeach's willful misconduct or gross negligence.

Participants agree that neither they, nor any of their heirs, personal or legal representatives, or family members will bring suit or make a claim for illness, injury, loss or damage to property, or loss of life resulting from the negligence (but not the willful misconduct or fraudulent conduct) of EcoTeach, its employees, directors, owners, officers, agents, contractors or affiliated organizations as a result of my participation in this trip. Participants also agree that they knowingly waive any and all claims of any nature they may have against EcoTeach other than those arising solely from EcoTeach's willful misconduct or fraudulent conduct.

Photo and Media Release: Participants are often included in photos and other media we create during our trips or that are shared with us by other participants. Our purpose is to produce educational and outreach materials associated with the subject matter and logistics of our programs. We appreciate being able to use the images and recordings created during the course of our trips and by signing your Registration Form you are granting permission for discretionary use of your picture, recording, writing, or projects to be used in our educational resources, website, Facebook, YouTube, Instagram, or other printed or electronic information related to our programs all without compensation to you. Responsibility / Student Code of Conduct: The responsibility for the participants' well-being and behavior will rest with the participants and with school staff on student trips, and not with EcoTeach. EcoTeach expects participants to act maturely and assume personal responsibility at all times. The use of alcohol by minors and illegal drug consumption is not permitted. Minor participants agree to: dress and act respectfully at all times; respect the property of all hotels and lodges on this trip; treat each other with respect (no bullying); and respect the authority of the chaperones and local guides (realizing that sometimes you need to simply do what they say for purposes of group safety and cohesion). Minor participants affirm that they will not use drugs or alcohol products and will not acquire any tattoos or body piercing during the trip. Participants will be returned to the U.S.A or their country of departure, at their expense, if their behavior is considered inappropriate or unsafe by EcoTeach in its sole discretion.

Documentation: It is the participant's responsibility to ensure they carry proper and valid documentation. Participants should review entry requirements to ensure they have the most current information; as of 6/2016, U.S. citizens traveling to Peru are required to carry a passport valid at least six months with at least 2 blank pages in the visa section. Participants carrying passports from countries other than the United States should check with the Embassy of the country where they are traveling to for entry requirements.

Immunizations / Health: The Center for Disease Control and Prevention (CDC) in the U.S.A. provides information regarding required and recommended vaccines and immunizations for travel to other countries here: <http://wwwnc.cdc.gov/travel/destinations/list>. By making a deposit with EcoTeach you certify that you have reviewed the CDC's information for the country where you are traveling.

Prevention of Bug Bites: Given the presence of mosquitoes, sand flies, and other insects in the country where you are traveling, and the risks associated with mosquito- and insect-borne illnesses, we request that you visit the CDC website which offers excellent advice on reducing risks by avoiding mosquito and other bug bites (<http://wwwnc.cdc.gov/travel/page/avoid-bug-bites>) and provides recommendations on the use of insect repellent (<http://www.cdc.gov/westnile/faq/repellent.html>). By making a deposit with EcoTeach you certify that you have reviewed the CDC information on avoiding bug bites and the use of insect repellent.

Warnings: Though we have taken participants from 2 to 80 years old, our trips are not for everyone. Many of our activities require hiking or walking on uneven trails and soft sand, crossing rivers, swimming and snorkeling, and other similar or dissimilar activities and therefore require a high degree of physical fitness and stamina. It is your sole responsibility to ensure that you are healthy and fit enough to participate in the tour. Good physical and mental health are essential for the enjoyment of these active, adventure trips. You may travel in rugged areas far removed from modern medical facilities. Good physical conditioning is recommended as preparation for all trips. By forwarding the deposit and this signed Registration Form, you certify that you do not have any physical or other conditions that would create a hazard for yourself or other travelers or affect other people's enjoyment of the tour. It is essential that any participant with a medical condition requiring regular or special treatment or which may be affected by vigorous activity, high altitude, heat, cold, other natural phenomenon, or particular foods, notifies EcoTeach in advance of travel. If you are a hardy and flexible traveler, you will enjoy the trip. We suggest you consult with your personal physician if you have any health-related problems, concerns or questions. Although we have not had a problem to date, we have been advised to inform you that venomous snakes are found in all parts of Peru and may pose a health hazard.

WARNING: Although EcoTeach stresses safety in all aspects of its programs, PLEASE BE AWARE that travel of any type, and participation in the real and exciting activities of eco-tourism and cross-cultural studies, can be inherently dangerous and always involves the risk of serious injury, illness or death.
